SUBJECT: Resilience Hubs & Networks Grant

Action Requested: Council approval for submission of project for grant.

<u>Discussion</u>: The Resilience Hubs and Networks Grant offers grants to organizations or individuals who wish to develop, expand, or strengthen a resilience hub or network in our community. Staff attended a webinar on this grant recently and learned that the grant intends to fund a lot of various solutions to emergency preparedness. As shown in the attachment, the City could use the grant to send people to CERT training, purchase emergency communications equipment such as satellite broadband, satellite phones, GMRS, generators and more. Since the City has expressed interest in all of these, this is a good grant to apply for.

In addition, we can also apply for one of the typed packages for a cache. Each package is complete with everything needed to put one together. The only separate thing that isn't included is fencing; however, the City can apply for fencing as a separate grant that is part of the overall grant submission. If the grant is awarded for one of these packages, the package will be purchased and installed through the grantor's program meaning they'd purchase the box, supplies, coordinate the installation and so on.

The grantees noted in the training that they do reserve the right to fund the grant in part or the whole, which is why it makes sense to apply for various pieces to make the most potential use of the grant. Depending on the ultimate location of the cache site, staff recommends Type 2 or Type 3.

Grant submissions are due April 30, 2024. Part of the grant is that there is additional, free grant application support assistance from Portland State University the City can take advantage of in developing the grant application.

Budget Impact: No match required.





SUBJECT: OPRD Local Government Grant Program

<u>Action Requested</u>: Council approval of project to apply for Oregon Parks and Recreation Department Local Government Grant Program.

<u>Discussion</u>: Oregon Parks and Recreation has two grants that are open for the City to apply to. One is for a Small Grant (due May 1) and the other is a Planning Grant (due May 15). The Small Grant is a good solution to help with funding the rehabilitation to our City Park. The Council approved \$75,000 in the budget last year to do the upgrade. Staff have investigated options to resurface the playground. Recently, staff have been advised by crew that the playground equipment itself is in need of upgrade as well.

Staff would like to work with the grants administrators to apply for the Small Grant program to resurface and replace the City park playground, including updating for ADA accessibility requirements, which is something the City doesn't have at this time.

In addition, the Parks Master Plan has not been updated since 2012 and to help the City determine priorities and needs, staff would like to apply for the Planning Grant to update the Parks Master Plan.

<u>Budget Impact</u>: FY 23/24 has \$75,000 set aside for playground. The program requires at least a 20% match for cities with a population under 5,000 so this set aside provides the funds necessary for match.

<u>Recommendation</u>: Council approval for staff to continue to work on applying for a Small Grant for the playground rehabilitation project and a Planning Grant to update the Parks Master Plan.
